Rule 56.1 (a 56.1 statement). • In the 56.1 statement, the moving party must list, in individually numbered paragraphs, important facts that the party argues are not in dispute. • To oppose a motion for summary judgment, in addition to a memorandum of law, you must submit your own statement responding to the other party's 56.1 statement.

An affidavit is a written statement that contains important facts you want the judge or the master to know about.You swear it under an oath (or affirm) before a registry clerk or a lawyer.“To swear” means you promise that the information contained in the affidavit is true. granted, based on your sworn statement. You do not have to have an EPO to get a PPO, and the respondent (abuser) does not have to be at the hearing. If a PPO is granted, it will last 15 days, or until the final Protective Order hearing. The judge will give you the date for the final hearing and it will also be included on the PPO.
